Fire Safety Order To be completed every 2 years

To be completed once a year

A copy of the gas safety certificate must

be sent to tenent and local authorities

Failure to be compliant

If you fail to complete your fire safety checks you could face an unlimited fine and/or up to 2 years in prison

Failure to be compliant

Standard fine of £6,000 for each failure

Insurance could be invalidated of noncompliance of the regulations

A criminal conviction for noncompliance which is a minimum of 6 months in prison

In most serious cases prosecution for manslaughter can be brought against you and would mean a court case

Notice to vacate

within 28 days of check

Ensure all relevant documents to allow notice have been issued: gas certificate, how to rent guide, EPC, Deposit registration

Make sure that the eviction isn't retaliatory under section 33 of the Deregulation Act

Ensure issue statutory two month notice to quit

Electrical Safety EICR report every 5 years or change of tenancy

) Ensure national standards are met

Supply a copy of report to tenants **28 days** after receiving request for report

Where the report shows that remedial or further investigation work is necessary this work needs to be completed within **28 days**, or shorter if specified in the report

Ensure Electrical Installations in rented properties are inspected and tested by a qualified and competent person every **5 years** or when the tenancy changes.

Supply written confirmation of the completion of remedial works from the electrician to the tenant and the local authorities within **28 days** of the completion of the works Supply local authorities with a copy of this report within 7 days of receiving a request for a copy

Retain a copy of the report to give to the inspector and tester who will undertake the next inspection and test

Failure to be compliant

Fine of up to £30,000

If negligence results in death or injury, or you persistently fail to comply you are likely to face time in prison

Legionella Risk Assessment Every 2 years or when new tenancy begins

- Identify potential hazard and level of risk
- 🔵 Identify who is at risk
- Putting adequate control measures in place to minimise risk
- Recording the findings of the assessment
- **)** Reviewing the assessment as needed

Failure to be compliant

While not a legal requirement in England and Wales in the same way that is expected of the EICR report or gas safety, landlords still have a general legal duty of care to protect the health and safety of their tenants. This includes ensuring their property's water is safe to drink and use. Tenancy Deposit protection Within 30 days of payment

Landlords MUST give contact details to tenants for the DPS as well as details of the scheme

Failure to be compliant

Tenants can claim up to 3 times the amount of the deposit from the landlord

Right to rent checks All landlords have the responsibility to prevent those without lawful immigration status from accessing the private rented sector

- Check which adults will be living at the property
- Ask each of them for original documents that prove they can legally live in the UK
- Check their property documents to ensure that they have the right to rent residential property
- Make and retain copies of these documents, recording the date that the check was made

Failure to be compliant

First fine: £500 Further fines: £3,000

Smoke and Carbon Monoxide Alarm To be checked the day tenants move in

Landlords need to ensure that they meet the Decent Homes Standard and continue to maintain their homes to at least this standard. Failure to be compliant

Fined up to £5,000 Per Breach
